On November 16, 2011 at approximately 9:50 PM Sheldon Fire, Rescue , EMA and Ambulance personal were paged to the scene of a motor vehicle accident 2 ½ miles north of Sheldon on Monroe Ave. The accident involved a single vehicle rollover. Following the accident the driver of the pickup was observed fleeing the scene on foot.

O'Brien County Sheriff's deputies responded to the scene and with the assistance of members of the Sheldon Fire Department they began looking for the suspect. A thermal imaging device was used to locate and track the movement of the suspect. O'Brien County Sheriff's deputies located the suspect approximately 25 minutes later hiding underneath a bridge approximately one mile from the accident site.

The suspect was identified as 20 year old Cesar Arizmendi Molina of Sheldon. Investigation showed that Molina was intoxicated at the time of the accident and was placed under arrest for Operating While Intoxicated, Failure to Maintain Control and Failure to have A Valid Drivers License. Molina was transported to the O'Brien County Jail on the charges. Further investigation revealed that Molina is not a US Citizen and that he was illegally in the United States. Immigration and Customs Enforcement Agency has issued a detainer for possible deportation of Molina.

Nature: **Controlled Substance Arrests**
The O'Brien County Sheriff's Office reports the arrest of two Omaha men on alleged drug charges following a traffic stop at approximately 5:00 PM on August 30, 2011. The traffic stop occurred on Highway #18 approximately three and one half miles west of Sanborn. An O'Brien County deputy sheriff stopped a vehicle for a traffic violation and upon further investigation of suspicious activity by the occupants of the vehicle, the deputy found approximately three and one quarter pounds of processed marijuana in the vehicle. Initially the passenger in the vehicle provided a false name. During further investigation officers were able to obtain his correct identity and learned that the subject was wanted on a federal arrest warrant out of Omaha, Nebraska.
The driver of the vehicle, Harold L Taylor age 62 of Omaha, Nebraska, was arrested for possession of controlled substance. The charge, a serious misdemeanor is punishable by up to one year in jail and up to an \$1875.00 fine. The passenger in the vehicle, Edward Allyn Smith age 31 of Omaha, Nebraska, was arrested for Possession of a Controlled Substance with Intent to Deliver and Failure To Affix a Drug Tax Stamp. Both charges are class D felonies and are punishable by up to five years in prison and up to a \$7500 fine. He was also arrested on the outstanding Federal arrest warrant.
Taylor and Smith were transported to the O'Brien County Jail and booked in on the charges. Each of them appeared in O'Brien County Magistrate court the following morning and Smith's bond was set at \$10,000. Smith is also being held on the federal warrant out of Omaha, Nebraska for the charge of Conspiracy to Distribute and Possession with Intent to Distribute five grams or more of crack cocaine. Taylor's bond was set at \$1000. Both subjects will make appearances later in O'Brien County District Court.
The O'Brien County Sheriff's Office was assisted in the investigation by the Sanborn Police Department, the Iowa State Patrol and the Sioux County Sheriff's Office K-9 team.

Caveat: All persons are innocent until proven guilty.

The scam involved a person telephoning the resident and advising the resident that a "grandson" was in trouble and needed money right away! The person calling indicated he was an "attorney" for this grandson and they needed to do a "wire transfer" via Western Union right away. This was done in more than one phone call. The resident lost over \$9,000 to this scam.

Residents should NOT SEND MONEY right away. They should attempt to check out the whereabouts of the "grandson" or other person they are being asked to send money about. Sending money via wire transfers via Western Union and other wire transfer companies should always be checked out before sending any money.

In some cases the scam artist will call back more than once and attempt to get additional money from the victim.

Residents are asked to call their law enforcement agency if they are contacted for these types of situations to possibly check out what the caller is telephoning about. It may be discovered a scam and by law enforcement having received prior complaints on similar scams, they may be able to stop you from being another victim.

Gillespie then crossed back across the road and impacted the south guardrail. Gillespie's vehicle received damage to both the front and back of the car. Hartley Ambulance and Hartley Fire were also on scene. Gillespie was taken to Sanford Sheldon Hospital.
