**Narrative**

DRIVER OF UNIT 001 WAS EASTBOUND ON 320TH ST NEAR THE INTERSECTION OF PIERCE AVE; DRIVER OF UNIT 001 SLOWED DOWN AND STOPPED DUE TO A VEHICLE IN FRONT OF HER STOPPED AND WAITING TO TURN NORTH ON PIERCE AVE; DRIVER OF UNIT 002 ADMITTED TO LOOKING DOWN AND NOT PAYING ATTENTION AND DID NOT SEE THE DRIVER OF UNIT 001 SLOW DOWN AND STOP; DRIVER OF UNIT 002 RAN INTO THE BACK OF UNIT 001; DRIVER OF UNIT 001 WAS UNINJURED AND DROVE VEH HOME; DRIVER OF UNIT 002 WAS UNINJURED AND REQUESTED A TOW COMPANY TO PULL THE FRONT BUMPER OFF OF THE DRIVER SIDE TIRE; UNIT 003 WAS NOT INVOLVED IN THE COLLISION
